- (iii) Age: - 25-45 years (Relaxation of 5 years in case of SC/ST/BC).

The candidate of ex-servicemen category be recruited upto the age of 45 years plus continue military service added by three years.

- (iv) Pay Scale: - 9300-34800 with the Grade Pay of Rs. 5400/-.

2. Essential qualifications and experience for the post of Assistant Secretary:-

- (i) Graduation and knowledge of Hindi/Sanskrit/Urdu/Punjabi upto Matric standard.
- (ii) Five years experience in Social and development activities with record in dealing with different projects and assignments and quality of initiative and leadership.

The candidates are strictly advised to apply online well in time without waiting for last date of submission of online application. No offline application form will be accepted by the office. Eligibility with regards qualifications, experience and other conditions etc. will be determined as on last date of submission of online application forms i.e. 16.03.2020 (Closing date). Application fees can be submitted through online mode only using Net Banking or Debit Card/Credit Card upto 24:00 hrs. Mid night of closing date using only the link provided by on website. Fee paid through any other link will not be accepted and Indian Red Cross Society, Haryana State Branch, Chandigarh will not be responsible for its refund.

- (ii) A Screening test will be taken before the interview. The screening test will be conducted tentatively in the month of April, 2020. A Separate announcement showing exact dates, times and venue of the tests will be issued in the due course of time. The Candidate are advised to visit our website regularly.
- (iii) Candidates are advised not to send the hard copy of the application form. If any Candidates sent the hard copy of the application form, the same will not be entertained.
